# I ELECTRONIC PAYMENTS

If you have a vendor that takes Credit Cards or ACH payments:

- The vendor **should** open a portal and pass the person to the payment processor and hold **no financial** information.
- If the vendor holds the financial information for any **time period** (batching at the end of the day is cheaper than doing it live), then they **must be** PCI certified, licensed by the state and have extensive security certifications.
- If they don't and they have a security breach the people effected will be coming for the **group with the deepest pockets**.
