



Soldiers' and Sailors' Civil Relief Act (SSCRA)

• Originally adopted 1940

Amended during Gulf War 1991

SCRA adopted in 2003

- Clarified language from the SSCRA
- Provides protections to Reserves and National Guard when on Active Duty Orders
